ProGreen Synthetic Grass has been in business over 25 years and produces all products in the USA. The materials are guaranteed against UV degradation and manufacturer defects for a period of fifteen (15) years from the date purchase and in accordance with ProGreen's Statement of Warranty Terms and Conditions.

Warranty shall not cover any defects or damage to ProGreen Synthetic Grass which derives from normal wear and tear, negligence, misuse or abuse, vandalism, machinery, animals, fire, chemical reactions, acts of God or damage due to excessive heat, including the effect of the sun's energy when magnified by glass or reflective surfaces. For the purposes of this warranty, UV stability failure is deemed to have occurred if the original tensile strength of the product measured by ASTM test methods decreases more than 50 percent from the original. Warranty proration is as follows: years 1 to 8 (100%); years 9 to 12 (50%); years 13 to 15 (25%).

Any repairs or alterations made to the product that have not been done through an authorized party may be excluded from this warranty. ProGreen's liability under this warranty is limited to the material value of the item to be repaired or replaced and shall not have any other obligation or liability in connection with any matter or thing, including without limitation, damages for personal injury or damages related to lost revenue, increased costs, downtime costs and all other indirect or consequential damages. The repair or replacement of the turf is at ProGreen's sole discretion

Defective subsurface preparation, failures in the subsurface after installation or other installation issues that might arise are not covered under this warranty. If an authorized installer is involved, please refer to the Installation Warranty issued upon receipt of the work.. No person or party shall create any obligation or liability for ProGreen and only the guarantee as expressed herein shall apply.

The warranty is not valid if product is not paid in full and not registered within thirty days of installation by filling out the warranty registration form below and mail it directly to ProGreen. Warranty claims must be made in writing to ProGreen Synthetic Grass within fifteen (15) years from the date of purchase and within thirty (30) days of learning of the cause giving rise to a claim. This warranty is non-transferable and extended to the original retail purchaser only. The warranty does not apply to off-quality or obsolete products or products with face weights less than 50 ounces per square yard.
